### MEMORANDUM

**TO:** Honorable School Board Members

**SUBJECT:** Permission to Place Purchase Order to SirsiDynix  
Annual Software Support for Library System

On June 22, 2004, the Board approved a negotiated contract (in file in the Purchasing Department) with SirsiDynix (Sirsi). The District uses software supplied by Sirsi to support its library system at 81 sites. The contract for maintenance on this system has been renewed annually by the Board since that date (latest November 1, 2011.)

As Sirsi holds the copyright for this software, its maintenance is considered sole source under Florida Administrative Rule 6A-1.012(11)(b). We are asking for approval in the amount of \$72,983.40 to cover the contract year January 1 – December 31, 2012. A purchase order in the amount of \$36,491.70 for the term January 1 – June 30, 2013 will be placed upon Board approval. The remaining 50% balance of \$36,491.70 will be placed under a separate purchase order for encumbrance during the next fiscal year. Payments will be made by the Information Services Department quarterly, in arrears.

I, Scott Askew, having been first duly sworn under oath, state the following:

Sirsi Corporation d/b/a SirsiDynix ("SirsiDynix") is the developer and/or sole source provider for all SirsiDynix software and specialized services. The SirsiDynix SYMPHONY integrated library system ("SYMPHONY ILS") product was developed at private expense by SirsiDynix. SYMPHONY ILS is a proprietary software product that is only available from SirsiDynix and SirsiDynix retains the exclusive trademark, copyright, trade secret and/or patent rights to the SYMPHONY ILS software. The SYMPHONY ILS software is provided only to those users that have signed a licensing agreement, therein agreeing to protect the confidentiality of the proprietary information and trade secrets of SirsiDynix' SYMPHONY ILS software. SirsiDynix has sole knowledge of the development of the software and certain configuration requirements that are exclusive to the SYMPHONY ILS software. Consequently, only SirsiDynix is able to sell and maintain the software as well as continue to make further enhancements in the SYMPHONY ILS software.

SirsiDynix is the library automation vendor for libraries, pursuant to agreements signed by both parties. As such, SirsiDynix provides maintenance and support for the complete system for such libraries. As software is added to the system, SirsiDynix requires that such libraries' software and specialized services be purchased directly from SirsiDynix in order to ensure continued support and compatibility of the new software with the existing system.
