Recommendation:

Recommend acceptance of RFPs from School Kids Healthcare and School Nurse Supply as noted on the attached tabulation sheet, as the responsive, responsible proposals having the highest points and meeting written specifications.

Term of Contract:

The intent of this RFP is to establish a three-year contract, renewable annually by mutual consent, with multiple vendors to purchase health and athletic supplies on an "as-needed" basis to be used throughout the District. The first year of this contract shall be effective from February 20, 2013 through February 19, 2014.

Notations and Exceptions:

Each RFP was evaluated and points assigned according to the following criteria as outlined in the specifications: Cost (20), Vendor Inventory (20), Minimum Order Requirements (5), and Delivery/Free Shipping Requirements (5).

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.

Recommend rejection of the proposals from Kentron Health Care, Inc. School Health Corporation and Alert Services, Inc. as the mandatory attorney signature was not provided on the principal place of business section of the RFP. Additionally, Alert Services, Inc. did not meet the free shipping requirements.

Recommend rejection of the proposal from Fischer Scientific Company as they did not meet the free shipping requirements.

Recommend rejection of the proposals from MFAC and School Specialty as they were disqualified at bid opening for failure to submit pricing.

Recommend rejection of the proposal from S&S Worldwide as they could not supply at least 50% of the most frequently purchased health and athletic supply items as outlined in the RFP document.

Due to the unique nature of health and athletic supplies purchased by schools throughout the District, we are requesting permission to negotiate with interested parties to obtain up to four (4) additional health and athletic supply vendors. The final negotiated contracts will be forwarded to a future Board meeting for approval.
