### MEMORANDUM

RE: Bid #10-080-LR Relocation of Portables  
Five Month Extension of a Three-Year Contract  
JLC Mobile Home Transport

On April 20, 2010, official action (attached) was taken to award the above-referenced bid to JLC Mobile Home Transport. This bid is a three-year contract, renewable annually based upon mutual consent of the parties. The third year of the agreement will expire on April 20, 2013. The bid document allows the District to extend the period and quantities of this bid, or any portion thereof, for an additional time not to exceed 365 days from the date of the third-year expiration.

Considering services have been satisfactory, Jeff Knappins, Owner, JLC Mobile Home Transport was contacted to determine his willingness to enter into the five month extension of the agreement. As such, he has agreed in writing (attached) to enter into the five month extension of the agreement. This extension will allow Maintenance Services to avoid an interruption in service during a critical time as the majority of these relocations need to take place prior to the start of the 2013 – 2014 school year.

It is my recommendation at this time to enter into the five month extension of the agreement with the vendor noted above. The five month extension of the contract will cover the period of April 21, 2013 through September 20, 2013.
