**Term of Contract:**

This is a three-year contract, renewable annually upon mutual agreement of both parties, for the purchase of Golf and Utility Cars – District-Wide. The first year of the contract for Part A: Golf Cars will commence on April 16, 2013 and continue through April 15, 2014. To sync up dates, the first year of Part B: Utility Cars will commence on May 7, 2013 and continue through April 15, 2014.

**Notations and Exceptions:**

Part A: Recommend award to West Coast Golf Cars, Inc. as being the lowest and best, responsive and responsible bidder meeting written specifications.

Part B: Recommend rejection of the bid from Golf Car Depot for failure to meet the specified vehicle load capacity, cargo area, plywood deck with drop down rails, and tilting bucket cargo area. Recommend award to Fairway Golf and E Cars, LLC. as the lowest and best, responsive and responsible bidder meeting written specifications.

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.

Savings were determined by averaging all bids submitted and subtracting the awarded vendor's bid price.
