Fourth Year of a Five Year Contract Renewal

Clover Creek Foods

On July 5, 2011, official action (attached) was taken to award the above-referenced bid to Clover Creek Foods for the purchase of milk and milk products This is a five year bid renewable annually based upon mutual consent of both parties. The third year period covers August 1, 2013 through July 31, 2014.

Considering services have been satisfactory, Tony Cherry, Vice President was contacted to verify his willingness to enter into the fourth year period of the agreement. As such, Tony Cherry has agreed in writing (attached).

The terms and conditions of the bid allow for price adjustments at the annual renewal based upon the change in the Producer Price Index (PPI) published by the Bureau of Statistics, U.S. Department of Labor, using Series ID: #PCU48411-48411, Not Seasonally Adjusted, Group: General freight trucking, local. A price adjustment decrease of 0.997 has been made and is in accordance with the PPI published allowance.

Therefore, at this time, it is my recommendation to enter into the fourth year period of the agreement with a price adjustment decrease of 0.997% with Clover Creek Foods. The fourth year period of the contract will cover the period of August 1, 2014 through July 31, 2015.
