On April 15, 2014 the Board approved the adoption of Intensified Algebra from Agile Minds which will serve as the instructional materials to support the acquisition of the mathematical standards for students in Algebra 1A and 1B classes. At this time, the Office for Teaching and Learning is requesting to place purchase orders not to exceed \$350,000 directly from Agile Minds. Under the Department of Education Rule 6A-1.012(11) (b), the requesting of bids from three (3) or more sources is waived for the purchase of educational tests, textbooks, printed instructional materials where such materials are purchased directly from the producer or publisher, the owner of the copyright, and exclusive agent within the state, a governmental agency or a recognized educational institution. Agile Minds is the copyright holder for Agile Mind course programs (see attached).

**SUBJECT: Purchase of Secondary Mathematics Materials** 

On April 15, 2014, the Board approved the adoption of Intensified Algebra from Agile Minds, which will serve as the instructional materials to support the acquisition of the mathematical standards for students in our Algebra 1A and 1B classes. We are now asking for approval to purchase these materials directly from Agile Minds, who is the publisher and producer of this program, and anticipate expenditures of approximately \$350,000.00, which will include materials and licensing for the next 5 years, as well as professional development for teachers and administrators.

The funds to purchase these materials will come from the instructional materials categorical allocation for 2013-2014, which is the first year in the adoption cycle for 6-12 Mathematics.

We also ask the Board for permission to execute a contract with Agile Minds at a future date, should it be necessary as negotiations are finalized.
