The Food and Nutrition Services Department is seeking permission to "piggy-back" the St. Clair County Board of Education bid 924 for Juice and Related Beverage Products.

Under DOE Rule 6A-1.012(6), the Board may make purchases at or below the unit prices in contracts awarded by other governmental agencies. A competitive process was conducted through the St. Clair County Board of Education that resulted in an award for Juice & Related Beverage Products and the vendor who was awarded under this contract, Trident Beverage d/b/a Juice Alive is willing to extend the same terms and conditions of this bid to our District. It is my recommendation to "piggy-back" the St. Clair County Board of Education bid #924.

The Food and Nutrition Services Department reports show that approximately 140,000 servings of juice and related beverage products (Fruit Slush) were sold last year. Gross sales were approximately \$117,000.00. Product and container costs were approximately \$60,000.00 resulting in a net profit of \$57,000. The approximate expenditure for these products is \$85,000.00 a year.
