One-Year Extension to Three-Year Agreement

RFP 11-031-AZ, Construction Management Services, West Work Group

Ajax Building Corp., Cutler Associates, A.D. Morgan Corp.

On July 27, 2010, official action was taken to award the above-referenced RFP to Ajax Building Corp. The terms of the RFP permit the Construction Services Dept. to negotiate with Ajax for construction management services, in accordance with the provisions of F.S. 287.055. The Board renewed this RFP for its second term on July 26, 2011 and for its third term on July 24, 2012. All documentation regarding the original action and subsequent renewals is on file in the Purchasing Services Dept.

The scope of the Work Group includes the projects outlined in the RFP's Attachment A, per the Planning Guide for Construction Services Work Projects, which was approved by the Board on January 19, 2010. The scope also includes any District-defined "emergency" work for the west side of the county during the term of the RFP. If we cannot reach accord with Ajax on any given project, we have the ability to negotiate, in turn, with Cutler Associates and The A.D. Morgan Corp.

As services have been satisfactory, Construction Services has requested permission to extend the three-year term of this RFP by one year, for the period July 27, 2013 – July 26, 2014. All firms have agreed in writing (attached) to this extension. We are requesting Board approval for the contract term extension, and permission to issue purchase orders regarding these projects as needed, based upon funding as approved in the Planning Guide for Construction Services Work Projects.
