A Plus Nurse Temps, Inc.

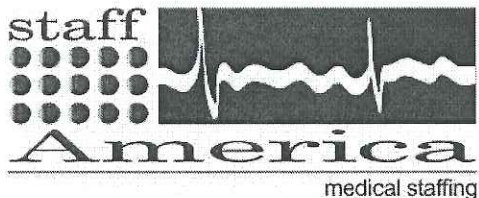
