On April 15, 2014, the Board approved the adoption of Glencoe Florida Math, which is a McGraw-Hill program that will serve as the instructional materials to support the acquisition of Mathematics standards in grades 6-8. As part of this adoption, McGraw-Hill has custom designed materials to support our Advanced Mathematics students at the schools who adopted their program. The above-referenced materials are a sole source as McGraw-Hill is the publisher and producer. The materials covered under this contract are exempt from the competitive pricing requirements as outlined in DOE's Section 6A-1.012(7).

It is my recommendation that the Board approve the purchase of the above referenced materials totaling \$200,000. Due to the dollar amount exceeding \$50,000, this request is being forwarded for your consideration and subsequent approval. The funds to purchase these materials are from the instructional materials categorical allocation for 2014-2015.
