SUBJECT: Direct Negotiated Contract with Premio Computer Inc.
eSembler Teacher Gradebook and Parent Access Software

On May 4, 2010, official action was taken to enter into a new contract with Premio Computer Inc. This program implements an enterprise-wide, electronic gradebook to automate attendance-taking, support classroom management, facilitate the collection of student grades, and enhance parent/school communication.

Every year since 2005 (inception of the original contract) we have received permission to place a purchase order to Premio to cover maintenance and support services for the software. Please see the attached memo from John Simon, Director of Technology and Information Services, and Ed Mutell, Supervisor of Technology and Information Services, for further information. The contract term will be September 1, 2013 – August 31, 2014, and is renewable annually at the mutual agreement of the parties. The terms and conditions of the contract were approved in March 2010 by Nancy Alfonso, Board Attorney. We are permitted to acquire these types of services under Florida Administrative Rule 6A-1.012(14).

We are requesting renewal of this contract for the next term, and permission to place purchase orders totaling \$87,080 for maintenance, support and reporting using general funds. Please contact John Simon or me if you have any questions.

Subject: Premio Computer, Inc., eSembler Teacher Gradebook and Parent Access Software

On April 9, 2005, the district awarded a direct negotiated contract to Premio Computer, Inc. This contract established an enterprise-wide electronic gradebook, called eSembler, to automate attendance collection, support classroom management, facilitate student grade collection, and enhance parent/school communication.

A new contract was Board approved on May 4, 2010 with Premio, Inc. to continue the use of eSembler. I am now requesting Board approval to place a purchase order in the amount of \$85,680 to Premio, Inc. to cover the cost of the annual renewal as outlined in the Board approved contract. An additional \$1400 will also be due for Annual State Standards support. Funding for this product will continue to be from the general fund.
